2. The initial release will be followed in **July 2022** by Service Issue 1, which will include not only updates to the first 23 chapters but will add a further nine including topics on pre-trial procedure:

Exceptions, applications to strike out, irregular proceedings, amendment of pleadings and documents, extension or abridgement of time, condonation, revival of rule nisi, barring and removal of bar, summary dismissal of actions or defences, set-down of trial actions and preparation for trial, discovery, inspection and production of documents, pre-trial conference, special cases, the separate determination of issues, and interim damages awards.

The inclusion of this service ensures the work will provide you with comprehensive commentary on everything you need to know in preparation for a trial.

Future service issues will continue to keep existing material updated while progressively covering further chapters, which will be housed in two further binders to cater for the remainder of the 53 chapters, including commentary relating to the Supreme Court of Appeal, the Constitutional Court and a number of special procedures.
