REFUGEES AMENDMENT ACT 12 OF 2011 (GG 34560 of 26 August 2011)^{*}

Date of commencement: Immediately after the commencement of the Refugees Amendment Act 33 of 2008

Amends ss. 1, 4, 8, 8C, 8E, 21B, 24, 24A, 24B, 27, 36 & 38, and *substitutes* the words 'Refugee Status Determination Officer', wherever they occur, with the words 'Status Determination Committee' in the Refugees Act 130 of 1998

IMMIGRATION AMENDMENT ACT 13 OF 2011 (GG 34561 of 26 August 2011)[†]

Date of commencement: to be proclaimed

Inserts s 9A, *substitutes* ss 13, 23 & 35, *repeals* ss 24 & 46, and *amends* the Preamble, ss 1, 4, 7, 9, 10, 10A, 14, 15, 19, 21, 22, 26, 27, 29, 30, 43, 49 & 50 and *substitutes* the word 'permit' or 'permits', wherever it occurs in the Immigration Act 13 of 2002, with the word 'visa' or 'visas', as the case may be, except in cases where reference is made to a permanent residence permit; and there is an amendment effected by any of the sections of this Act, excluding this section; the words 'temporary residence permit' or 'temporary residence permits', wherever they occur in the Act, with the word 'visa' or 'visas', as the case may be; the word 'condition' or 'conditions', wherever it occurs in the Act, with the words 'terms and conditions', except in cases where the phrase 'terms and conditions' or 'terms or conditions' are used; and the words '21 years', wherever they occur in the Act, with the words '18 years'
