**DEPARTMENT OF JUSTICE AND CONSTITUTIONAL DEVELOPMENT****NO. 959****04 SEPTEMBER 2017****DESCRIPTION: AREAS OF JURISDICTION OF OFFICES OF SHERIFFS IN THE LOWER AND SUPERIOR COURTS [Sheriffs Act, 1986 (Act No. 90 of 1986)]**

I, John Harold Jeffery, Deputy Minister of Justice and Constitutional Development, acting under sections 3(2)(a) and 3(4) of the Sheriffs Act, 1986 (Act No. 90 of 1986), hereby:

In respect of Government Notice No 1554, as contained in Government Gazette No 40489 dated 12 December 2016, amend the sheriff's areas mentioned under Column "B", within the superior and lower court jurisdiction mentioned under Column "A" of **Schedule 1**, as described through the point-to-point descriptions under Column "C", with effect from 1 September 2017.

In respect of the vacant superior and lower court sheriff areas, as well as those sheriff areas affected by the alignment of the vacant sheriff areas to the rationalized magisterial district boundaries as mentioned under Column "B" within the superior and lower court jurisdiction indicated under Column "A" of **Schedule 2**, describe the sheriff areas through the point-to-point descriptions under Column "C", with effect from 1 September 2017.

In respect of the vacant superior court sheriff areas mentioned under Column "B" within the superior and lower court jurisdiction indicated under Column "A" of **Schedule 3**, describe the vacant sheriff areas through the point-to-point descriptions under Column "C", with effect from 1 September 2017.

In respect of the superior and lower court sheriff areas indicated under Column "B" within the superior and lower court jurisdiction indicated under Column "A" of **Schedule 4**, describe portions of the existing sheriff areas that are not aligned to the rationalised magisterial district boundaries through the point-to-point descriptions under Column "C". These areas will continue to be served by the existing Sheriff, but from the court in which jurisdiction the described portion resorts, with effect from 1 September 2017.

The maps for the corresponding point-to-point descriptions of the sheriff areas mentioned in Schedules 1-4 of this Notice are available on the websites of the Department of Justice and Constitutional Development ([www.justice.gov.za](http://www.justice.gov.za)) and the South African Board for Sheriffs ([www.sheriffs.org.za](http://www.sheriffs.org.za)).

<b>COLUMN C Point to Point description of the Port Elizabeth West Sheriff Service Area</b>	
<p>Starting from the point of intersection of the southern suburb boundary of Khayamnandi and Uitenhage Road (R368), proceed along the R368 becoming the M14 in a general south easterly direction until it intersects with the north western suburb boundary of Govan Mbeki. Proceed in a northerly direction along the suburb boundary until it becomes the Chatty River and continue along the Chatty River until it intersects with the Uitenhage Road (R75). Proceed in a south easterly direction along the R75 to the intersection with Bethelsdorp Road. Proceed in a southerly direction along Bethelsdorp Road that becomes the eastern suburb boundary of Missionvale, Salt Pan and Windvogel that is followed to the intersection thereof with Stanford Road. Proceed in a south easterly direction along Stanford Road to the intersection with the N2. Proceed in a southerly direction along the N2 to the point of intersection with the northern boundary of Schauderville being the western prolongation of Highfield Road. Proceed on Highfield Road to the intersection with Cottrell Street. Proceed in a southerly direction along Cottrell Street and then north easterly on Burt Road then northerly direction along Kempston Road (M8) (to exclude Life Mercantile Hospital) to the M8/ N2 intersection and continue on the M8 prolongation (service road) to the intersection with the suburb boundary of Deal Party. Proceed in a westerly and then northerly direction along the eastern suburb boundary of Deal Party to the point of intersection with the low-water mark. Proceed in a southerly direction along the low-water mark to the intersection of the low water mark and the north easterly prolongation of the southern suburb boundary of Humewood. From this point of intersection proceed in a south westerly direction along the southern suburb boundary of Humewood to the intersection with the eastern road reserve of Beach Road. Proceed along Beach Road which becomes Humewood Road (M4) to the intersection with Driftsands Drive (M13). Proceed in a south westerly direction along Driftsands Drive to the intersection of Driftsands Drive with the north eastern prolongation of the northern suburb boundary of Forest Hill. From this point of intersection proceed in a south westerly direction along the prolongation of and the northern suburb boundary to the point of intersection with La Rochelle Drive/ Forest Hill Drive/ Allister Miller Road. Proceed in a general westerly direction along Allister Miller Road to the intersection with the southern prolongation of the western suburb boundary of South End. Proceed in a northerly direction along the prolongation of and the western suburb boundary of South End to where it intersects with the Baakens River. Proceed in a westerly direction along the Baakens River to the point of intersection with the western suburb boundary of Mill Park. Proceed along the western suburb boundary of Mill Park in a northerly direction to the point of intersection with Cape Road (R102). Proceed in a westerly direction along Cape Road to the intersection with 3<sup>rd</sup> Avenue (Newton Park). Proceed in a northerly direction along 3<sup>rd</sup> avenue to the intersection with the southern suburb boundary of Schauderville at Burt Drive. Proceed in a north westerly direct along the southern suburb boundary of Schauderville, (portion of) Park side and Malabar to the point of intersection of the southern boundary of Malabar and the north western beacon of the northern suburb boundary of Western Hills. From the point of intersection use the prolongation (in a straight line) of the north western beacon of Western Hills to the prolonged intersection thereof with the eastern suburb boundary of Malambar at Godetta Drive. Proceed in a northerly direction along the western suburb boundary of Malabar until it intersects</p>	

with the northern suburb boundary of Parsons Vlei. Proceed in a north westerly direction along the northern boundary of Parsons Vlei to where it intersects with the southern suburb boundary of Bloemendal. Proceed along the southern suburb boundary of Bloemendal until it intersects with the eastern boundary of the farm Kakkerlaks Vley 400. Proceed in a northerly direction along the eastern boundary of the mentioned farm to the most north eastern beacon thereof and prolong the mentioned boundary along the suburb boundary of Port Elizabeth NU to the point of interaction with the southern suburb boundary of Khayamnandi on the Uitenhage Road (R368), being the starting point.

Starting from the point of intersection of Van Stadens Pass (R102)(becoming Old Cape Road (R102)), the Municipal boundary being the Van Stadens River, proceed in a easterly direction along the middle of Van Stadens Pass (R102) becoming Old Cape Road (R102) to the intersection with CJ Langenhoven Drive/ 1 <sup>st</sup> Avenue. Proceed in a southerly direction along the middle of 1 <sup>st</sup> Avenue which is also the eastern suburb boundaries of Newton Park, Glenhurd and Mangold Park. Proceed in a southerly direction along the mentioned eastern suburb boundaries until the prolongation thereof intersects with the Baakens River. Proceed along the Baakens River in a general easterly direction to the point of intersection with the eastern suburb boundary of Walmer at 1 <sup>st</sup> Avenue (Walmer). Proceed in a southerly direction along the suburb boundary of Walmer until the prolongation thereof intersects with Allister Miller Road. Proceed in an easterly direction along the middle of Allister Miller Road to where it intersects with Forest Hill Drive/ La Rochelle Drive, which is also the north western beacon of the suburb Forest Hill. Proceed along the northern suburb boundary of Forest Hill until the prolongation thereof intersects with the northern road reserve of Driftsands Drive. Proceed along Driftsands Drive in a north easterly direction until it intersects with Humewood Road. Proceed in a south easterly direction along the eastern road reserve of Humewood Road which becomes Beach Road. Proceed along Beach Road in a south easterly direction up where it intersects with the northern suburb boundary of Summerstrand. Proceed along the suburb boundary in a north easterly direction until it intersects with the low-water mark. Proceed along the low-water mark in a southerly and general westerly direction along the coast line to the intersection with the Municipal boundary at Van Stadens River. Proceed in a northerly direction along the Municipal boundary being the Van Stadens River to the point of intersection with the Van Stadens Pass (R102) being the starting point.

Point to Point description of the <b>Randburg West</b> Sheriff Service Area	
<p>Starting from the intersection of R512 and the Crocodile river, proceed in a north easterly direction along the Crocodile river until it intersects with the southern boundary of Lindley 528, then proceed east along the southern boundary of Lindley 528 until the intersection with the Jukskei River. Proceed in a southerly direction along the Jukskei River until the intersection with the southern boundary of the farm Rietfontein 532. From there proceed in an easterly direction along the southern boundary of farm Rietfontein 532 until the intersection with the western boundary of the farm Diepsloot 388 (Diepsloot Nature Reserve). Proceed in a southerly direction along the western boundary of farm Diepsloot 388 until the intersection with the southern boundary of farm Diepsloot 388. From there, proceed east, generally south and east again along the southern boundary of farm Diepsloot 388 and Diepsloot A.H until the intersection with the R 511. Proceed south along the R511 until the intersection with the southern boundary of Fourways Gardens. From there proceed south west along the boundary of Fourways Gardens until the intersection with Cedar Road. Proceed in a south easterly direction with Cedar Road until the intersection with Witkoppen Road (R564). From there, proceed in a westerly direction with Witkoppen Road (R564), until the intersection with the western boundary of Fourways. Proceed in a southerly, easterly and south easterly direction with the western boundary of Fourways and then the western boundary of Norscot until the intersection with the N1 Highway. Proceed in a south westerly direction along the N1 Highway until the intersection with the southern boundary of Douglasdale. Proceed in a south westerly direction along the southern boundary of Douglasdale until the intersection with the eastern boundary of Olivedale then southwest along the eastern boundary of Olivedale until the intersection with Jacaranda Avenue. Proceed in a westerly direction with Jacaranda Avenue until the intersection with President Fouché Drive and then south along President Fouché Drive until the intersection with the R512 (Malibongwe Drive). Proceed along the R512 in a westerly and northerly direction until the intersection with the southern suburb boundary of Kaya Sands. Proceed in a westerly direction along the southern and eastern suburb boundary of Kaya Sands to the most northern suburb beacon of Kaya Sands and proceed in a general southerly direction along the western suburb boundary of Kaya Sands to the most southern beacon that intersects with Boundary Road. Proceed generally south along Boundary Road until the intersection with the southern boundary of Zandspruit 191 (Cosmo City). Proceed in a north westerly and northerly direction along the boundary of farm Zandspruit 191 until the intersection with the southern boundary of Nooitgedagt 534, from there proceed in a northerly direction along the eastern boundary of Nooitgedagt 534, across the R114 and the N14 Highway until the intersection with the southern boundary of farm Bultfontein 533. Proceed in a westerly, north easterly and north westerly direction along the boundary of farm Bultfontein 533 until the intersection with the southern boundary of farm Botesdal 529. From there proceed in a north westerly and then north easterly direction along the boundary of farm Botesdal 529 until the intersection with the R512. From there in a north westerly direction along the R512 until the intersection with the Crocodile River, which is the starting point.</p>	

**COLUMN C****Point to Point description of the Randburg South West Sheriff Service Area**

Starting at the point of intersection between Beyers Naude Drive and the Western boundary of Sonnedal A.H, proceed in a general Northerly direction along the Western boundary of Sonnedal A.H. until the point of intersection with the Western boundary of the Farm Zandspruit 191 (Cosmo City). From the point of intersection proceed in a general Southerly and then Easterly direction along the Northern suburb boundary of Sonnedal A.H. to the point of intersection with Boundary Road so as to exclude the entire Cosmo City with all its extensions from the Service Area. From the point of intersection, proceed in a general Northerly direction along Boundary Road and continue in a straight line prolongation to the south western suburb boundary of Kaya Sands. From the point of intersection proceed in a general northerly direction along the western suburb boundary of Kaya Sands to the northern beacon of Kaya Sands that intersects with Homestead Road. From the point of intersection proceed in a general southerly direction along Homestead Road until the intersection with Hilston Road. Proceed in a general easterly direction along Hilston Road which becomes Kaya Sand Street and which is also the western suburb boundary of Kaya Sands to the point of intersection with Malibongwe Drive. Proceed in a South easterly direction along Malibongwe Drive to the intersection with President Fouché Drive. From there proceed in a Northerly direction along President Fouché Drive to the intersection of Jacaranda Avenue. Proceed in a general Easterly direction along Jacaranda Avenue to the intersection with Kays Avenue. Proceed in a Northerly direction along Kays Avenue to the intersection with Cumberland Avenue. Proceed in a general Easterly direction along Cumberland Avenue until the intersection with Homestead Avenue. Proceed in a South easterly direction along Homestead Avenue, across Bram Fischer Drive, into Peter Place and proceed along Peter Place to the intersection with William Nicol Drive (M81). From there, proceed in a southerly direction along William Nicol Drive to the Northern intersection with Jan Smuts Avenue (M27). Thence proceed in a Northerly direction along Jan Smuts Avenue (M27) to the intersection with Conrad Drive. Proceed in a Westerly direction on Conrad Drive for approximately 120 meters to the point of intersection between Conrad Drive and the Spruit. From the said intersection proceed in a southerly direction along the middle of the Spruit up to the closest point of the Spruit intersecting with Rustenburg Road (M71). Proceed in a Southerly direction along Rustenburg Road to the intersection with Tana Road, West in Tana Road until the intersection with Hofmeyer Road, then generally southwest on Hofmeyer Road until Preller Road. Proceed southwest on Preller Road until the intersection with Beyers Naudé Drive (M5). Proceed northwest along Beyers Naude Drive until the intersection with the southern boundary of Randpark Ridge. Proceed northwest along the boundary of Randpark Ridge until the western Boundary of Randpark Ridge. From there, proceed north along the western boundary of Randpark Ridge, north along the western boundary of Bush Hill A.H. until the intersection with Beyers Naude Drive (M5). Proceed in a north westerly direction along Beyers Naude Drive until the intersection with the western boundary of Sonnedal A.H, which is the starting point.

**COLUMN C****Point to Point description of the Sandton North Sheriff Service Area**

Starting at the north western beacon of the Farm Rietfontein 532, proceed in an easterly and then southerly direction along the northern and eastern boundaries of the mentioned farm to the point of intersection with the R28. Proceed in a general easterly direction along the R28 to the point of intersection with the north eastern suburb beacon of Diepsloot. Proceed in a general southerly direction along the eastern suburb boundary of Diepsloot continuing on the northern suburb boundary of Bridle Park AH to the intersection thereof with Summit Road R562. Proceed in a general easterly direction along Summit Road to the intersection with the eastern boundary of Knoppieslaagte No. 385 and the north eastern corner of Bridle Park A.H, proceed in a south easterly direction along the R562 until the intersection with the western boundary of Blue Hills 397. Proceed in a south westerly direction along the western boundary of Blue Hills 397 as well as the western



boundary of Blue Hills A.H until the southern boundary thereof. Proceed in an easterly direction with the southern boundary of Blue Hills A.H until the intersection with the north eastern corner of Crowthorne A.H. Proceed in a generally southern direction along the western boundary of Crowthorne A.H until the intersection with the southernmost corner of Crowthorne A.H. and the R55. From there proceed south along the R55 until the intersection with the northern boundary of Woodlands. Follow the northern boundary of Woodlands in a general western direction until the intersection with the eastern boundary of Woodmead. From here, follow the south westerly and southern boundary of Woodmead until the intersection with the Sandspruit, which is also the western boundary of Woodmead. Proceed north along the Sandspruit until the intersection with the N1 Highway. Proceed west on the N1 until the eastern boundary of Petervale. Proceed in a south westerly direction along the eastern boundary of Petervale until the eastern boundary of Bryanston. From there, proceed in a southerly and south westerly direction along the boundary of Bryanston until the intersection with William Nicol Drive. Proceed north along William Nicol Drive until the intersection with Peter Place. Proceed west along Peter Place over Braamfisher Drive into Homestead Avenue until the intersection of Homestead and Cumberland Avenue. From here, proceed in a south westerly direction with Cumberland Avenue until the intersection with Kays Avenue, proceed south west along Kays Avenue until Jacaranda Avenue. Proceed northwest along Jacaranda Avenue until the intersection with the eastern boundary of Olivedale. Proceed in a north easterly direction along the eastern boundary of Olivedale until the southern boundary of Douglasdale then in a north easterly direction along the southern boundary of Douglasdale until the intersection with the N1 Highway. Proceed north east with the N1 until the intersection with the western boundary of Norscot. Proceed in a general northern direction along the western boundary of Norscot and then north westerly along the western boundary of Fourways until the intersection with Witkoppen Road (R564). Proceed north east along the R564 until the intersection with Cedar Road. Proceed in a north westerly direction along Cedar Road until the north western boundary of Witkoppen. Proceed in a north easterly direction along this boundary of Witkoppen (which is the south eastern boundary of Fourways Gardens) until the intersection with William Nicol Drive (R511). From there, proceed north along the R511 until the north eastern beacon of Treesbank A.H. which is also the southern suburb boundary of Diepsloot. Proceed in a general westerly direction along the southern and eastern suburb boundaries of Diepsloot to the point of intersection with the southern farm boundary of the farm Rietfontein 532. Proceed in a general easterly and northerly direction along the southern and eastern farm boundaries of the Farm Rietfontein 532 up to the north western beacon of the Farm Rietfontein 532, which is the starting point.

Beginning at the low water mark of the Boesmans River, proceed along the middle of the Boemans River in a north westerly direction to the point of intersection with the north western beacon of the farm Harvest Vale 300. Proceed in an easterly direction along the northern boundary of the Farm Harvest Vale 300 and along the outer boundaries of the following farms so as to include the mentioned farms in the service area: Harvest Vale 300, Aquavista 299, Wayside 297, Sidbury Toll Outspan 295, Glenfillan 293, and Frome 179. From the North eastern beacon of the farm Frome 179, which is also the point of	

intersection with the Bloukrans River, proceed in a general north easterly direction along the middle of the Bloukrans River to the point of intersection with the south western beacon of the farm Blaauwkransvlakte 38. From the point of intersection proceed in a general north easterly direction along the outside boundaries of the following farms so as to include them in the service area: Blaauwkransvlakte 38, Moodiekop 37, Waai Plaats 36, Waaiplaats Outspan 35, Farm 29, Kap River Farm 28, Coombs Vale 3, Chersty 5, Forest Cliff 6, Buffelsfontein 7, Radies Vley 8, Huntshoek 611 to the point of intersection with the Groot-Vis River. From the point of intersection proceed along the middle of the Groot-Vis River in a general southerly direction to the low water mark at Ndlambe. Proceed along the low water mark in a general southerly direction to the point of intersection of the low water mark with the Boesmans River, the point of beginning.

Point to Point description of the **Cathcart** Sheriff Service Area

Beginning at the point where the prolongation of the north-western boundary of the farm Riversdale 1 intersects the middle of the Swart-Kei River, proceed generally south eastwards along the middle of the said Swart-Kei River to the middle where the Swart-Kei River intersects with the middle of the Great Kei River along the northern boundary of the farm Inverket 240. From the point of intersection proceed along the middle of the Great Kei River in a general south easterly direction to the intersection thereof with the eastern boundary of the Farm Inver Thomas 245. Proceed generally south-westwards along the boundaries of the following properties so as to include them in this area: The said Farms Inver Thomas 245, Stockdrift 272, Horsefell 273, Bombazai 274, Northcliff 275, Runnymede 303, Dryhurst 304, Quaca Heights 340, Wartburg Falls 339, Farm 338, Farm 337, Northern portion of the Farm 336, Farm 335, Hove 125, Woodford 179, Hurst 178, Cullean 177, Cassilis 176, Ailsa 175, Tavistock 172, Ditchling 171, Highgate 168, Farm (Mountain Top) 167, Grasslands 165, Groenfontein 163, Farm 162 and Farm 34 and to south western beacon of the last mentioned Farm 35 so as to include Farm 35. From the south western beacon of the Farm 35 prolong the south boundary of Farm 35 in a straight line to the point of intersection with the eastern boundary of the Farm Sunnyside 778. Proceed in a general northerly direction along the outer boundaries of the Farms Sunnyside 778, Hill Side 777 and Merino 181 so as to exclude then from the area. From the point of intersection of the eastern boundary of the farm Merino with the southern beacon of the Farm Eweka 184, proceed in a general northerly direction along the outer boundaries of the following farms so as to include them in the area: The said Farm Eweka 184, New Glenholm 182, Warfield 173, Woodstock 174, Cooling 154, Glencoe 153, Glenfinlas 101, Kinross 103, Elstow 94, Deep River 343, Woodburn 95, Claremont B 44, Waterdown 43 to the point where the north eastern beacon of the Farm Waterdown 43 intersects with the Western boundary of the farm Lange Draai 42. Proceed in a northerly direction for 186 meters along the said farm boundary, from this point proceed in a north easterly direction across the R67 and from there in a south easterly direction to the point of intersection with the north eastern boundary of the farm Lange Draai 42 (The portion of the farm Langedraai west of the R67 therefore resorts under Queenstown). From the point of intersection proceed along the outer boundaries of the following farms so as to include them in the area: The remainder of the farm Lange Draai 42, Branksome 41, Melrose 24, Hilton 23, Table Farm 22, Farm 363, Wellington 3, Cloetdale 2 and the said Riversdale I, the point of beginning.

Beginning at the northernmost beacon of the farm Klipplaatsdrift 450, proceed clockwise along the boundaries of the following farms so as to include them in the area: Klipplaatsdrift 450, Queenstown RD 526, Good Hope 187, Merino Rust 68, School Fontein 67, Kleinfontein 66, De Rust 65, Nooitgedacht 59, Sharon 60, Thorny Hoek 61, Hopefield 150, Rockwood 151, Prospect 152, Clifton Vale 154, Greenfontein 156, Evertan 158, Everdale 159, Queens Park 163, Grobelaars Grave 210, Imwani 218, Queenstown RD 517, Hopewell 220, Glen Thorn 290, Rennie Vale 288, Cathcart 287, Farm 443 and the said Farm Hendham 283, to the point where the south-eastern boundary of the said Farm Hendham 283 intersects the middle of the Swart-Kei River; thence generally westwards along the middle of the said Swart-Kei River to the point where the prolongation north eastwards of the south-eastern boundary of the Farm Peninsula 294 intersects the middle of the said Swart-Kei River; thence clockwise along the said prolongation and the boundaries of the following farms so as to include them in this area: The said Farm Peninsula 294, Rookwood 387, Marlborough 393, Falstaff Vale 397, Guilford 399, Alva 406 and Gallawater 409 and protruding the Klipppaat River so as to include the Farm Lange Draai 42 to the point where boundary again intersects with the Klipplaats River.
