The Children's Act 38 of 2005 gives effect to certain rights of children as contained in the Constitution; sets out principles relating to the care and protection of children; defines parental responsibilities and rights; makes further provision regarding children's courts; provides for partial care of children, for early childhood development, for the issuing of contribution orders, for prevention and early intervention, for children in alternative care, for foster care, for child and youth care centres, and drop-in centres; makes new provision for the adoption of children and for inter-country adoption; gives effect to the Hague Convention on Inter-country Adoption; prohibits child abduction and gives effect to the Hague Convention on International Child Abduction; makes provision for surrogate motherhood and creates certain new offences relating to children; and for matters connected therewith.
